- Late ISF Filings are subject to \$5,000 CBP penalty.

## **Export Compliance for USA Exporters:**

Electronic Export Information (EEI) needs to be filed when the value of the commodity classified under each individual Schedule B number is over \$2,500 or if a validated export license is required to export. The exporter is responsible for preparing the EEI and the carrier or customs broker files it with U.S. Customs and Border Protection (CBP) through the AES or AES Direct.
